Contributors to this Issue

Johannes Becke is a professor of Israel and Middle East Studies at the Hochschule für Jüdische Studien and a coopted member of the Philosophical Faculty at Heidelberg University. He has studied at the University of Heidelberg, the University of Illinois Urbana-Champaign, and Cairo University and held a postdoctoral fellowship at Oxford University. His research focuses on Arab-Israeli relations, with a focus on comparative perspectives on Zionism and Israeli state formation. In the research training group "Ambivalent Enmity," his research focuses on Jewish-Arab transculturation in Israel/Palestine, shaped by both conflict and mutual fascination.

Nikolas Jaspert is a professor for Medieval History at the University of Heidelberg. He studied Medieval History, Hispanic Philology, and Art History at the Free University of Berlin, concluding with a thesis on the medieval history of Barcelona published as *Stift und Stadt: Das Heiliggrabpriorat von Santa Anna und das Regularkanonikerstift Santa Eulàlia del Camp im mittelalterlichen Barcelona (1145–1423) (Berlin: Duncker und Humblot, 1996). In the same year he joined the history department of Berlin's Free University as an assistant professor. From 1998 to 2005 he was Lecturer at the University of Erlangen-Nuremberg. Before joining Heidelberg, Jaspert was Full Professor for Medieval History at the Ruhr-Universität Bochum from 2005 to 2013. He is a Director at the Heidelberg Center for Transcultural Studies, and his academic work is centered on Mediterranean History, the history of the Iberian Peninsula, the crusades, medieval religious orders, and urban history.*

Joachim Kurtz is a professor of Intellectual History at the Heidelberg Centre for Transcultural Studies. He previously worked as an associate professor of Chinese at Emory University, Atlanta, and as a research group director at the Max Planck Institute for the History of Science in Berlin. He has studied at Hamburg, Beijing, Berlin, Shanghai, Göttingen, and Erlangen and held visiting positions at the Institute for Advanced Study in Princeton, the École des Hautes Études en Sciences Sociales in Paris, and the Institute for History and Philology at Academia Sinica in Taibei. His research focuses on cultural exchanges between China, Japan, and Europe, with special emphasis on philosophy, logic, political theory, translation studies, and the history of the book. In the context of "Ambivalent Enmity" he explores the global linkages of East Asian fundamentalist thought.

Derek Jonathan Penslar is the William Lee Frost Professor of Jewish History and the Director of the Center for Jewish Studies at Harvard University. He is also the Samuel Zacks Professor of Jewish History Emeritus at the University of Toronto. Penslar's research places the history of modern European Jewry, Zionism, and Israel in global comparative contexts. His books include *Jews and the Military: A History* (Princeton: Princeton University Press, 2013), *Theodor Herzl: The Charismatic Leader* (New Haven: Yale University Press, 2020), and *Zionism: An Emotional State* (Brunswick, NJ: Rutgers University Press, 2023). He is currently writing a book titled *The War for Palestine*, 1947–1949: A Global History. He is a past president of the American Society for Jewish Research, a fellow of the Royal Society of Canada, and an Honorary Fellow of St. Anne's College, Oxford.

Tanja Penter is Professor of Eastern European History and current director of the research unit for the study of Antiziganism at the University of Heidelberg. She is a member of the German-Ukrainian Historical Commission, the senate of the Hochschule für Jüdische Studien and the academic boards of IfZ Munich, IOS Regensburg, *Historische Zeitschrift*, Buchenwald Memorial, and the Northeast Institute Lueneburg. She is co-editor of the series *Osteuropa in Geschichte und Gegenwart*. Her research interests include comparisons of dictatorships, the Revolution of 1917, Soviet war crimes trials, compensation for Nazi crimes, the Soviet war in Afghanistan, nuclear heritage and post-Soviet politics of history. In the context of "Ambivalent Enmity" she studies experiences of violence, enmity, and dictatorship in twentieth-century Ukraine and Russia.

Svenja Taubner is a clinical psychologist and psychoanalyst and serves as full professor and director at the Institute for Psychosocial Prevention and Psychotherapy at the University of Heidelberg. She studied in Bremen and held academic positions at universities in Bremen, Ulm, Kassel, and Berlin. She was a fellow at the Hanse Institute of Advanced Study before she was appointed full professor at the University of Klagenfurt, Austria. Among her many interests are clinical applications, development, and research on mentalization-based treatments, transgenerational transmission of trauma, and the psychological understanding and treatment of aggression. She is president of the MBT-D-A-CH (MBT association in German-speaking countries) and a member of the German Scientific Psychotherapy Chamber.

Monica Juneja is professor of Global Art History at the University of Heidelberg. She was previously Professor at the University of Delhi and has held visiting positions at University of Vienna, Leibniz University Hannover, University of Zurich, and Emory University. Awards she has received include fellowships of the Maison des Sciences de l'Homme, the Alexander von Humboldt Foundation, the Getty Research Centre, the *Opus Magnum* award of the Volkswagen Foundation, and most recently the Meyer-Struckmann Prize for Humanities and Social Sciences. Her research focuses on transculturation and visual representation, the disciplinary formation of art history in South Asia, heritage and architectural histories, with a special focus on conflicts surrounding memories and monumental remains of past empires in South Asia. She has recently published *Can Art History be Made Global? Meditations from the Periphery* (Berlin: De Gruyter, 2023).

Sebastian Harnisch is a professor for International Relations and Foreign Policy at the University of Heidelberg, and a member of the Executive Board of the Heidelberg Center for American Studies (HCA). He holds degrees in history and political science from Trier University and was a research fellow at the Japan Center for International Exchange, Columbia University, and Yonsei University. He has taught at Trier and the Federal Armed Forces University in Munich and served as a visiting professor at Beijing Foreign Studies University, Al-Farabi Kazakh National University, and China Foreign Affairs University. Harnisch has published numerous books, edited volumes, and articles on comparative foreign and security policy, international relations theories, cybersecurity, non-proliferation of weapons of mass destruction, and climate change policy issues. He is a member of the Academic Advisory Board of Foreign Policy Analysis, as well as co-editor of the series Foreign Policy and International Order (Nomos) and the Oxford Research Encyclopedia for Foreign Policy Analysis.
